

Hiring a Contractor

As you prepare to hook up to the new system, a qualified contractor can help you determine the work required on your property and the costs. The RM of St. Andrews has compiled a list of contractors meeting all of the technical requirements for this type of work (see next page of this fact sheet) and some details to keep in mind.

Responsibilities of the homeowner and contractor

The contractor doing the work on your property is considered your agent, not the agent of the RM. The company you hire must:

- Meet the special requirements for contractors installing underground utility services, including knowledge, licensing, bonds and insurance;
- Follow all requirements for underground service connections, including permits, inspections and technical specifications; and
- Provide a 12-month warranty to both you and to the RM for the service connection.

Information about costs

The cost of this work on individual properties will vary, depending on the condition and suitability of the existing equipment, the underground services already in place and many other factors. Based on information from contractors and previous installations, the average cost is about \$7,000.

Here are a few things to keep in mind when obtaining estimates:

- You will be reimbursed for sewer line installation over 200 feet. You are responsible for
 having a contractor drill and lay up to 200 feet of sewer line from the tank to the property
 line. If the distance from your tank to the property line is more than 200 feet, the RM will
 reimburse you for the additional expense, provided the cost has been pre-approved and you
 can provide an invoice and proof of payment.
- You don't need to pay for your water meter. The RM has contracted a company to install
 water meters supplied by the RM on properties in the service area at no additional cost to
 homeowners. Contact the RM office to arrange for your water meter installation.
