1. Call to Order

5. Wastewater System Connection Process:

- a) Permit Process:
- -R. Borsa reviewed the draft permit and permit process.
- -Chair Pike mentioned that the fees that are listed on the permit were discussed In-Camera.
- -R. Borsa mentioned the Permit has been distributed to Council.
- -J. Sul and L. Hunt suggested the damage deposit may not be required for residents that have already installed the private line as there will be no contact to the Curb Stop valve.
- -R. Borsa concurred.

b) Meter Program

- -R. Borsa reviewed the tentative meter tender and installation program from discussions with the Manitoba Water Services Board (MWSB).
- -MWSB is making funds available from Phase 1 monies unspent for the meters.
- -As Phase 2 costs are not complete available funds are not clear at this time. The allowable budget from Phase 1 at this time allows for the purchase of approximately1500 meters.
- -The purchase may be staged to reduce storage and handling.

c) Additional Connection Discharges

- -R. Borsa discussed the question raised about additional connections such as water softeners. Over the last few months R. Borsa has had discussions with Province who would now support softener discharge at grade if it is currently not causing any problems.
- -R. Borsa and CAO concur with this recommendation and would suggest leaving additional discharges as they are. If problems arise then it would need to be directed to the sewer system and would be addressed at that time.

7. Other Items - None

-R. Borsa to follow up with Stantec/MWSB regarding any chemicals used for corrosion control and any potential impact at the North End Water Pollution Control Centre.
